PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **G-11303** and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to **The Fraternal Order of Eagles, Eugene Aerie 275, c/o James E. Hooten, Secretary of PO Box 621, Eugene, Oregon 97440, phone 345-4253 or 688-9471, for use of the waters from one well,**
for the PURPOSE of **irrigation of 16.7 acres**

that the PRIORITY OF THE RIGHT dates from **August 23, 1984**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.21 cubic foot per second**

measured at the point of diversion from the **well**, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: **2255 feet North and 1740 feet West from the Southeast Corner of Section 10, being within the NW 1/4 SE 1/4 of Section 10, Township 17 South, Range 4 West, WM, in the County of Lane.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 17 South, Range 4 West, WM Section 10 SE 1/4 NW 1/4	0.417 acre
SW 1/4 NE 1/4	.803 acre
NE 1/4 SW 1/4	3.760 acres
NW 1/4 SE 1/4	11.720 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before **December 28, 1985**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, **1986**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **87**.
