PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11274 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Sportsman Park Water Association, by R.E. Davis, Chairman, PO Box 712, Wamic, Oregon 97063, phone (H)663-5359 or (W)227-1441, for use of the waters from Well 1 with back-up supply from Well 2, for the PURPOSE of irrigation of 3.0 acres and domestic use for 153 families including

for the PURPOSE of irrigation of 3.0 acres and domestic use for 153 families including the irrigation of not to exceed one-half acre lawn and noncommercial garden for each family, being 0.15 cubic foot per second for domestic use and 0.04 cfs for * that the PRIORITY OF THE RIGHT dates from August 15, 1984

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.19 cubic foot per second

measured at the point of diversion from the wells , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well 1 - 380 feet South and 310 feet East from Northwest Corner of the SW 1/4 SW 1/4 of Section 14, being within the SW 1/4 SW 1/4 of Section 14; Well 2 - 390 feet South and 1530 feet East from the Northwest Corner of the SW 1/4 SW 1/4 of Section 14, being within the SE 1/4 SW 1/4 of Section 14 both within ** A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

If for irrigation, this appropriation shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before February 8, 1986, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1986. Extended to October 1, 1991

Complete application of the water to the proposed use shall be made on or before October 1, 19 87. Extended to October 1, 1991
