PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11282 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Robert W. Loomis, Jr. of 9500 SE 352nd Avenue, Boring, Oregon 97009, phone 663-5737, for use of the waters from two wells, being 200 gallons per minute from Well 1 and 10 gpm from Well 2,

for the PURPOSE of irrigation, related nursery use and containerized nursery use being 95 gpm from Well 1 for irrigation, 200 gpm from Well 1 and 10 gpm from Well 2 for related nursery use, and 200 gpm from Well 1 and 10 gpm from Well 2 for * that the PRIORITY OF THE RIGHT dates from June 19, 1984

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 210

measured at the point of diversion from the wells , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well 1 - 2500 feet South and 2200 feet West from Northeast Corner, Section 27; Well 2 - 2450 feet South and 2420 feet West from the Northeast Corner of Section 27, both being within the SW 1/4 NE 1/4 of Section 27 both within Township 1 South, Range 4 East, WM, in the County of Clackamas. A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* containerized nursery use

Township 1 South, Range 4 East, WM Section 27 SW 1/4 NE 1/4 7.8 acres NW 1/4 SE 1/4 9.2 acres

If for irrigation, this appropriation shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

February 8, 1986, and shall thereafter be prosecuted with reasonable Actual construction work shall begin on or before diligence and be completed on or before October 1, 1986.

Complete application of the water to the proposed use shall be made on or before October 1, 19 87.
