PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11327 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Glenn A. Walters of 2813 Pacific Avenue, Suite C, Forest Grove, Oregon, 97116, phone 359-4453, for use of the waters from two wells, being 0.89 cubic foot per second from Well 2 and 0.024 cfs from Well 1 when available with any* for the PURPOSE of supplemental irrigation of 37.1 acres, containerized nursery stock and greenhouse use

that the PRIORITY OF THE RIGHT dates from December 7, 1984 for use from Well 2 and February 6, 1985 for use from Well 1

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.914 cubic foot per second, being 0.46 cfs from Well 2 for irrigation, 0.89 cfs from Well 2 for containerized nursery stock use and 0.024 cfs from Well 1 with any deficiency made** measured at the point of diversion from the Wells , or its equivalent in case of rotation with other water users.


The well is to be LOCATED: Well 1 - 1140 feet North and 2880 feet West; Well 2 - 900 feet North and 2900 feet West, both from the Southeast Corner of Section 2, both being within the SE 1/4 SW 1/4 of Section 2, Township 1 North Range 4 West, WM, in the County of Washington.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* deficiency in the available supply from Well 1 to be made up by appropriation from Well 2,

** up from Well 2 for greenhouse use.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before April 8, 1986 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1986 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 87.
