## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11357 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Clarence Simmons of 3472 Howell Prairie Road, NE, Silverton, Oregon, 97381, for use of the waters from Pratum Well,

for the PURPOSE of irrigation of 50.0 acres and supplemental irrigation of 14.2 acres

that the PRIORITY OF THE RIGHT dates from March 8, 1985

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.8 Cubic foot per second

measured at the point of diversion from the well , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 370 feet South and 2260 feet West from the N 1/4 Corner of Section 25, being within the NW 1/4 NW 1/4 of Section 25, Township 7 South, Range 2 West, WM, in the County of Marion.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at this time of perfection of this right.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before April 25, 1986, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1986.

Complete application of the water to the proposed use shall be made on or before October 1, 19 87.
