## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11345 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Clackamas Greenhouse, Inc. of 23646 Klupenger Road, NE, Aurora, Oregon, 97002, phone 678-1279, for use of the waters from Well 1 with back-up supply from Well 2, for the PURPOSE of

for the PURPOSE of nursery operations, being 50 gallons per mintue for greenhouse uses, 5 gpm for bulb storage uses and 15 gpm for warehouse uses

that the PRIORITY OF THE RIGHT dates from February 11, 1985

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 70 gpm

measured at the point of diversion from the wells , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well 1 - 1510 feet North and 550 feet East from the Southwest Corner of Section 34; Well 2 - 1554 feet North and 565 feet East from the Southwest Corner of Section 34, both being within the NW 1/4 SW 1/4 of Section 34, Township 3 South, Range 1 West. WM, in the County of Marion.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 3 South, Range 1 West, WM Section 34 NW 1/4 SW 1/4 Greenhouse, warehouse SW 1/4 SW 1/4 Greenhouse, warehouse, bulb storage

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before May 13, 1986 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 86 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 87.
