PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11390 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Crestview Farms, Inc. of 33366 S. Dryland Road, Molalla, Oregon, 97038, phone 829-2170, for use of the waters from three wells,

for the PURPOSE of irrigation and supplemental irrigation, being 45 gallons per minute from Wells 2, 3 and 4 for primary irrigation of 8.0 acres and 583 gpm from Well 4 for the supplemental irrigation of 207 acres (to bring amount of water up to full * that the PRIORITY OF THE RIGHT dates from May 21, 1985

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 628 gpm

measured at the point of diversion from the wells, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well 2 - 500 feet South and 2300 feet West from the Northeast Corner of Section 23, being within the NW 1/4 NE 1/4 of Section 23; Well 3 - 1300 feet South and 1430 feet West from the Northeast Corner of Section 23, being within the NW 1/4 NE 1/4 of Section 23; Well 4 - 500 feet South and 3160 feet West from **

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before July 2, 1986, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 86.

Complete application of the water to the proposed use shall be made on or before October 1, 19 87.
