PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **G-11040** and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to **Sundale Water Co-op Assoc.**, by **Corey, Byler, Rew, Lorenzen and Hojem** of **222 SE Dorion Avenue, Pendleton, Oregon, 97801**, phone **276-3331**, for use of the waters from two wells, being **0.09 cubic foot per second from Well 1 with any *** for the PURPOSE of **irrigation of 5.49 acres and supplemental irrigation of 1.40 acres**

that the PRIORITY OF THE RIGHT dates from **July 27, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.09 cfs**

measured at the point of diversion from the **wells**, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: **Well 1 - 240 feet North and 784 feet East from the W 1/4 Corner of Section 21; Well 2 - 220 feet North and 784 feet East from the W 1/4 Corner of Section 21, both being within the SW 1/4 NW 1/4 of Section 21, Township 2 North, Range 32 East, WM, in the County of Umatilla.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* deficiency in the available supply from Well 1 to be made up by diversion from Well 2, provided the total quantity from both wells shall not exceed 0.09 cfs,

Township 2 North, Range 32 East, WM Section 21 SW 1/4 NW 1/4 3.76 acres Primary
SE 1/4 NW 1/4 1.73 acres Primary
SE 1/4 NW 1/4 1.40 acres Supplemental

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before **July 29, 1986**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **86**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **87**.
