PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11413 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to William Lloyd Wendover of 1628 Dick George Road, Cave Junction, Oregon, 97523, phone 592-2985, for use of the waters from one sump well,

for the PURPOSE of frost protection on 3.5 acres

that the PRIORITY OF THE RIGHT dates from July 15, 1985

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 111 gallons per minute

measured at the point of diversion from the SUMP, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 400 feet North and 400 feet East from the W 1/4 Corner of Section 7, being within the SW 1/4 NW 1/4 of Section 7, Township 40 South, Range 7 West, WM, in the County of Josephine.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 40 South, Range 7 West, WM Section 7 SW 1/4 NW 1/4 3.5 acres Frost protection

The permittee shall record and submit annually to the Water Resources Department all pertinent data pertaining to use of water for frost control on forms furnished. Use of water under this permit shall be limited to the appropriation of water only to the extent that such appropriation does not interfere with or deplete the flow of Althouse Creek. Any depletion will require that use from the sump be shut down, since Althouse Creek has been closed to appropriation except for domestic, mining and power where no consumption of water is to be made.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before August 30, 1986, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1986.

Complete application of the water to the proposed use shall be made on or before October 1, 1987.
