PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11416 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Weyerhaeuser Company, a Washington Corporation, Tacoma, Washington, 98477, phone (503) 266-2018 Aurora, Oregon, for use of the waters from two wells, being 150 gallons per minute from Well 6 and 100 gallons per minute from Well 14 for the PURPOSE of irrigation of 20.5 acres and frost protection, being 115 gpm for irrigation and 250 gpm for frost protection. The use allowed herein for irrigation may be made anytime between February 1 and September 30, that water can be put to* that the PRIORITY OF THE RIGHT dates from July 29, 1985

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 250 Gallons Per Minute

measured at the point of diversion from the wells, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well 6 - 930 feet South and 2100 feet West from the Northeast corner of Section 18 being within the NW 1/4 NE 1/4 of Section 18; Well 14 - 840 feet South and 2710 feet West from the Northeast corner of Section 18 being within the NE 1/4 of the NW 1/4 of Section 18, both in Township 4 South, Range 1 East,**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* beneficial use by irrigation for immediate crop growth

** WM, in the County of Clackamas.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 and shall be further limited to a diversion of not to exceed 1.0 acre foot for each acre irrigated during the period from February 1 to March 31 of each year. The permittee shall record and submit annually to the Water Resources Department all pertinent data pertaining to use of water for temperature control (frost control) on forms furnished.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before April 17, 1987 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 87 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 88 .
