PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11389 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Charles D. Wavra of 8167 Oak Lane, Mt. Angel, Oregon, 97362, phone 845-6185, for use of the waters from three wells,

for the PURPOSE of irrigation and supplemental irrigation, being use from Wells #1, #2 and #3 for primary irrigation of 25.0 acres and use from Well #3 for supplemental irrigation of 298.3 acres

that the PRIORITY OF THE RIGHT dates from May 21, 1985

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 4.04 cubic feet per second

measured at the point of diversion from the wells , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well #1- 1800 feet South and 1850 feet West; Well #2- 1750 feet South and 950 feet West; Well #3- 2550 feet South and 520 feet West, all from the Southwest corner, DLC 41, being within Well #1- SW 1/4 SW 1/4; Well #2- SE 1/4 SW 1/4; Well #3- SE 1/4 SW 1/4, all in Section 11, Township 8 South, Range 2 West, *

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before **July 3, 1987**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **88**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **89**
