## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11487 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Jean R. Walker and Marilyn J. Walker of 28116 - 18th Avenue South #141, Federal Way, Washington, 98003, phone (206) 839-5152, for use of the waters from one well, for the PURPOSE of irrigation of 9.9 acres

that the PRIORITY OF THE RIGHT dates from March 7, 1986

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.12 cubic foot per second

measured at the point of diversion from the well, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 600 feet North and 1030 feet East from the Southwest corner of Section 3, being within the SW 1/4 SW 1/4 Section 3, Township 2 North, Range 33 East, WM, in the County of Umatilla.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 2 North, Range 33 East, WM Section 3	SW 1/4 SW 1/4	5.9 acres
	SE 1/4 SW 1/4	4.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Use of water under this permit shall be limited to appropriation of water only to the extent that such appropriation does not interfere with or deplete the flow of Umatilla River or any tributary thereof. Any depletion will require the well to be shut down pursuant to the Order of Withdrawal by the Water Resources Commission dated December 2, 1985, in the matter of withdrawal of certain unappropriated waters of the Umatilla River and its tributaries.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before July 3, 1987, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1988.

Complete application of the water to the proposed use shall be made on or before October 1, 1989
