PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11527 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Alan J. Kraemer of 13508 Marquam Road NE, Mt. Angel, Oregon, 97362, phone 845-6214, for use of the waters from one well,

for the PURPOSE of nursery operations on 20.0 acres, being 250.0 gallons per minute for containerized nursery stock use and 250.0 gpm for greenhouse use, provided the total quantity diverted shall not exceed 250.0 gpm, that the PRIORITY OF THE RIGHT dates from May 20, 1986

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 250.0 gallons per minute

measured at the point of diversion from the well, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 375 feet North and 275 feet East from the Southwest corner of Section 2, being within the SW 1/4 SW 1/4 Section 2, Township 6 South, Range 1 West, in the County of Marion.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before August 28, 1987, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1988.

Complete application of the water to the proposed use shall be made on or before October 1, 1989.
