PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11535 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Oregon State Parks Division, 525 Trade Street SE, Salem, Oregon, 97310, phone 378-5017, for use of the waters from one well,

park use (potable water in campgrounds) at Nehalem Bay State Park

that the PRIORITY OF THE RIGHT dates from

June 5, 1986

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.06 cubic foot per

measured at the point of diversion from the well , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 600 feet North and 2380 feet West from the East quarter corner of Section 32, being within the SW 1/4 NE 1/4 Section 32, Township 3 North, Range 10 West, WM, in the County of Tillamook.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before September 17, 1987, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 89 .
