## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11525 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Prairie Wood Products Inc., Box 386, Prairie City, Oregon, 97869, phone 820-3351, for use of the waters from two sump wells and shall be limited to any deficiency in the available supply of water from the John Day River allowed \* for the PURPOSE of Log deck sprinkling,

that the PRIORITY OF THE RIGHT dates from May 13, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.0 cubic foot per second,

measured at the point of diversion from the wells , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well #1- 1215 feet South and 920 feet West from the Northeast corner of Section 10; Well #2- 1770 feet South and 1115 feet West from the Northeast corner of Section 10, being within: Well #1- NE 1/4 NE 1/4; Well #2- SE 1/4 NE 1/4 both in Section 10, Township 13 South, Range 33 East, in the County \*\*  
A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before September 29, 1987, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 89 .
