PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11519 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to The Dalles Country Club, 4550 Highway 30 West, The Dalles, Oregon, 97058, phone 298-4045, for use of the waters from Well #1 when available with any deficiency in the available supply of water from Well #1 to be made up by appro- * for the PURPOSE of irrigation of 3.75 acres,

that the PRIORITY OF THE RIGHT dates from May 7, 1986 for use of 0.03 cubic foot per second and July 21, 1986 for use of 0.017 cubic foot per second,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.047 cubic foot per second,

measured at the point of diversion from the wells , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well #1- 840 feet North and 1125 feet West from the Southeast Section 17 and Well #2- 1510 feet North and 320 feet West from the Southeast corner of Section 17, being within the Well #1- SE 1/4 SE 1/4 Section 17 and Well #2- NE 1/4 SE 1/4 Section 17, Township 2 North Range 13 East, WM, in the County of **

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before October 21, 1987 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 89 .
