PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-5598 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Tyler Hansell of Route 1, Box 1824, Hermiston, Oregon, 97838, phone 567-8939, for use of the waters from four wells, being 1462.5 gallons per minute from each well,

for the PURPOSE of irrigation of 181.4 acres and supplemental irrigation of 869.08 acres,

that the PRIORITY OF THE RIGHT dates from August 12, 1971,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 5850.0 gallons per minute,

measured at the point of diversion from the wells , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well #1- 1290 feet North and 206 feet West from the Southeast corner of Section 4; Well #2- 1011 feet North and 165 feet West from the Southeast corner of the SE 1/4 NE 1/4 Section 9; Well #3- 949 feet North and 1031 feet West from Southeast corner of the SE 1/4 NE 1/4 Section 3; Well #4- 90 feet North and * A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* 1100 feet West from the Southeast corner of Section 28, being within Well #1-SE 1/4 SE 1/4 Section 4, Township 3 North, Range 27 East; Well #2-SE 1/4 NE 1/4 Section 9, Township 3 North, Range 27 East; Well #3-SE 1/4 NE 1/4 Section 3, Township 3 North, Range 27 East; Well #4-SE 1/4 SE 1/4 Section 28, Township 4 North, Range 27 East, WM, in the County of Umatilla.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before December 22, 1987, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88 • Extended to October 1, 1989 BC Extended to October 1, 1990, 10 -1-75

Complete application of the water to the proposed use shall be made on or before October 1, 19 89, 10-1-91, 10-1-95, 10-1-95
