PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11591 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Riverbend-Riverbank Water Improvement District (c/o E. Appel), 490 Southwest Riverbend Drive, West Linn, Oregon, 97068, phone (Bus.) 796-7185 (Evenings) 656-6105, for use of the waters from one well,

for the PURPOSE of Community service uses to include swimming pool and sanitary facilities at two buildings and group domestic supplies for 68 families including irrigation of lawns and gardens not to exceed one-half acre in area per family, * that the PRIORITY OF THE RIGHT dates from October 7, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 105.0 gallons per minute,

measured at the point of diversion from the well , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 680 feet South and 620 feet East from Northwest corner of Section 22, being within the NW 1/4 NW 1/4 Section 22, Township 3 South, Range 1 East, WM, in the County of Clackamas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* being 5.0 gallons per minute for community service uses and 100 gpm for domestic supplies,

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before February 26, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88.

Complete application of the water to the proposed use shall be made on or before October 1, 19 89 .
