### PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11567 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Wayne Trumbull of Route 3, Box 218, Milton-Freewater, Oregon, 97862, phone 938-5244, for use of the waters from one well,

for the PURPOSE of Irrigation of 2.61 acres,

that the PRIORITY OF THE RIGHT dates from August 1, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.065 cubic foot per second,

measured at the point of diversion from the well, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 63 feet North and 177 feet West from the Southeast corner of NW 1/4 NE 1/4 Section 26, being within the NW 1/4 NE 1/4 Section 26, Township 6 North, Range 35 East, WM, in the County of Umatilla.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 6 North, Range 35 East, WM Section 26 NW1/4 NE1/4 2.61 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, use of water under this permit shall be limited to appropriation of water only to the extent that such appropriation does not interfere with or deplete the flow of the Walla Walla River or any tributary thereof; any depletion will require the well to be shut down, since the Walla Walla River and its tributaries have been closed to further appropriation and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before March 17, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1988.

Complete application of the water to the proposed use shall be made on or before October 1, 1989.
