APPLICATION FOR A PERMIT

To appropriate the Ground Waters of the State of Oregon

I, MARVIN M. MCDOLE, do hereby make application for a permit to appropriate the following described ground waters of the state of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. Give name of nearest stream to which the well, tunnel or other source of water development is situated UMATILLA RIVER tributary of COLUMBIA R.

2. The amount of water which the applicant intends to apply to beneficial use is 4 cubic feet per second or gallons per minute.

3. The use to which the water is to be applied is IRRIGATION

4. The well or other source is located 115 ft. S and 90 ft. E from the NW corner of SEC 34 - T 4 N - R 27 E W M. S 90 35 E 661.52' from NW cor Sec 34

being within the NW 1/4 NW 1/4 of Sec. 34, Twp. 4 N, R. 27 E, W. M., in the county of UMATILLA

5. The PIPE LINE to be 1 miles in length, terminating in the E 1/2 NE 1/4 of Sec. 34, Twp. 4 N, R. 27 E, W. M., the proposed location being shown throughout on the accompanying map.

6. The name of the well or other works is M. MCDOLE - WELL # 2

DESCRIPTION OF WORKS

7. If the flow to be utilized is artesian, the works to be used for the control and conservation of the supply when not in use must be described.

8. The development will consist of 1 WELL having a diameter of 12 inches and an estimated depth of 70 feet. It is estimated that 70 feet of the well will require 3/8" wall x 12" casing. Depth to water table is estimated 55.50'

**CANAL SYSTEM OR PIPE LINE**

10. If pumps are to be used, give size and type 12" - 3 Stage Turbine

Give horsepower and type of motor or engine to be used 50 HP Electric Motor at well, plus 60 H.P. Booster Pump midway of field

11. If the location of the well, tunnel, or other development work is less than one-fourth mile from a natural stream or stream channel, give the distance to the nearest point on each of such channels and the difference in elevation between the stream bed and the ground surface at the source of development

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 2.96 cubic feet per second measured at the point of diversion from the well or source of appropriation, or its equivalent in case of rotation with other water users, from a well

The use to which this water is to be applied is Irrigation

If for irrigation, this appropriation shall be limited to 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be cased as necessary in accordance with good practice and if the flow is artesian the works shall include proper capping and control valve to prevent the waste of ground water.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

The priority date of this permit is August 28, 1958

Actual construction work shall begin on or before October 20, 1959 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1960

Complete application of the water to the proposed use shall be made on or before October 1, 1961
