## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11594 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions

This permit is issued to Cecil and Dorothy Byers of 3564 East 2nd Street, The Dalles, Oregon, 97058, phone 298-8154, for use of the waters from one well,

Domestic use for 15 families and irrigation of 2.0 acres, being for the PURPOSE of 0.016 cubic foot per second for domestic and 0.025 cfs for irrigation,

that the PRIORITY OF THE RIGHT dates from October 29, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.035cubic foot per second,

measured at the point of diversion from the well , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 560 feet North and 860 feet East from the Southewest corner of Section 31, being within the SW 1/4 SW 1/4 Section 31, Township 2 North, Range 14 East, WM, in the County of Wasco.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 2 North, Range 14 East, WM Section 31 SW1/4 SW1/4

Domestic use for 15 families and irrigation of 2.0

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before April 23, 1988 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 90 .
