## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Richard C. Smith of Box 2081 Kennedy Creek NE #5, Salem, Oregon, 97303, for use of the waters from one well,

for the PURPOSE of Irrigation of 160.0 acres,

that the PRIORITY OF THE RIGHT dates from November 4, 1983,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 2.0 cubic feet per second,

measured at the point of diversion from the well , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 15 feet North and 2655 feet West from the Southeast corner of Section 25, being within the SE 1/4 SW 1/4 Section 25, Township 26 South, Range 18 East, WM, in the County of Lake.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 26 South, Range 18 East, WM Section 25 NW1/4 SW1/4 40.0 acres SW1/4 S

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before May 27, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1989. Extended to October 1, 1990. Extended to October 1, 1991.

Complete application of the water to the proposed use shall be made on or before October 1, 19 90 .Extended to October 1, 1991
