PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11597 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Oregon Berry Packing Company, Route 6, Box 232, Hillsboro, Oregon, 97123, phone 640-2313, for use of the waters from three wells, being 20.0 gallons per minute from Well #5, 25.0 gpm from Well #6 and 90.0 gpm from Well #7, for the PURPOSE of Irrigation of 42.07 acres and food processing, to include filbert washing and berry processing, being 130 gallons per minute for irrigation and 100 gpm for food processing, that the PRIORITY OF THE RIGHT dates from November 12, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 135.0 gallons per minute,

measured at the point of diversion from the wells, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well #5- 858 feet South and 758 feet East; Well #6- 1654.7 feet South and 1321 feet East and Well #7- 1741.7 feet South and 1341 feet East, all from the Northeast corner of N.C. Richardson DLC #63, being within the (Well #5) SE 1/4 SW 1/4 Section 18; (Wells #6 and #7) NW 1/4 NE 1/4 Section 19, both of *

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before May 27, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 90 .
