PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11601 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Robert F. Fessler of 11796 Monitor - McKee Road, Woodburn, Oregon, 97071, phone 634-2231, for use of the waters from two wells,

for the PURPOSE of Nursery Operations to include use in greenhouses on 8.4 acres and use on containers on 28.4 acres, being 600 gallons per minute for greenhouse uses and 600 gpm for containers,

that the PRIORITY OF THE RIGHT dates from December 19, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 600.0 gallons per minute,

measured at the point of diversion from the wells, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well #1- 2000 feet South and 290 feet East from the NW 1/4 corner of NE 1/4 SE 1/4 Section 21; Well #2- 2090 feet South and 20 feet West from the Northeast corner of NW 1/4 SW 1/4 Section 22, being within the (Well #1) SE 1/4 SE 1/4 Section 21 and (Well #2) SW 1/4 SW 1/4 Section 22, both in Township 5 South,* A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* Range 1 West, WM, in the County of Marion.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before May 27, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 90 .
