PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11604 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Robert Fessler of 11796 Monitor - McKee Road, Woodburn, Oregon, 97071, phone 634-2231, for use of the waters from four wells,

for the PURPOSE of Greenhouse use on 12.3 acres,

that the PRIORITY OF THE RIGHT dates from December 19, 1986,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 400.0 gallons per minute.

measured at the point of diversion from the wells , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well #1- 265 feet South and 2595 feet East from the Northwest corner of Section 33; Well #2- 1485 feet South and 2420 feet East from the Northwest corner of Section 33; Well #3- 815 feet South and 2280 feet East from the Northwest corner of Section 33 and Well #4- 750 feet South and 2295 feet East from * A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* the Northwest corner of Section 33, being within the (Wells #1, #3 and #4) NE 1/4 NW 1/4; (Well #2) SE 1/4 NW 1/4 all of Section 33, Township 5 South, Range 1 West, WM, in the County of Marion.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before May 27, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89.

Complete application of the water to the proposed use shall be made on or before October 1, 19 $\,90\,$.
