## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11625 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Russell E. Noah of 538 Heather Lane, Roseburg, Oregon, 97470, phone 672-6703, for use of the waters from a sump,

for the PURPOSE of Supplemental irrigation of 8.1 acres.

that the PRIORITY OF THE RIGHT dates from February 24, 1987,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed second,

measured at the point of diversion from the SUMP , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 300 feet North and 850 feet East from the Southwest corner of Section 6, being within the SW 1/4 SW 1/4 Section 6, Township 27 South, Range 6 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 27 South, Range 6 West, WM Section 6 SW1/4 SW1/4 4.5 acres Section 7 NW1/4 NW1/4 3.6 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights and if it should be determined that waters in the sump are in hydraulic connection with surface waters, use of water during the period July 15 though September 30 shall be limited to the irrigation of a noncommercial garden not to exceed one-half acre in area, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before  $\frac{1}{100}$  June 30, 1988 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 90 .
