PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **G-11684** and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to **Gordon and Linda Wanner of 28211 South Dryland Road, Canby, Oregon 97013, phone 266-9277, for the use of water from one well,**

for the PURPOSE of **Irrigation of 82.36 acres,**

that the PRIORITY OF THE RIGHT dates from **July 24, 1987,**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **250 gallons per minute**

measured at the point of diversion from the **well**, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: **1350 feet North and 400 feet West from the Southeast corner of the William Offield DLC 42, being within the NE1/4 NE1/4 of Section 27, Township 4 South, Range 1 East, W.M., in the County of Clackamas.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre feet per acre for each acre irrigated during the irrigation season of each year, and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before **November 24, 1988**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 19 89**.

Complete application of the water to the proposed use shall be made on or before **October 1, 19 90**.
