## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11606 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Boeing Agri-Industrial Company of P.O. Box 139, Boardman, Oregon 97818, phone 481-2281, for the use of water from one well,

for the PURPOSE of irrigation of 5.0 acres and industrial uses to include washing of building floors and outside paved areas for cleaning and dust control, wetting areas for fire prevention and water for drinking and\* that the PRIORITY OF THE RIGHT dates from December 24, 1986 for industrial uses and September 4, 1987 for irrigation,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 49.0 gallons per minute, being 28.0 gpm for irrigation and 21.0 gpm for industrial uses

measured at the point of diversion from the well , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 130 feet South and 742 feet West from the Northeast corner of the Northwest Quarter of Section 15, being within the NE1/4 NW1/4 of Section 15, Township 3 North, Range 24 East, W.M., in the County of Morrow.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 3 North, Range 24 East, W.M., Section 10 SE1/4 SW1/4 Industrial use and 2.0 acres
Section 15 NE1/4 NW1/4 Industrial use and 3.0 acres

\* sanitary facilities,

The AMOUNT OF WATER used for irrigation, together with the the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre feet per acre for each acre irrigated during the irrigation season of each year, and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with prior surface water rights, as well as ground water rights of others, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before  $\frac{1988}{1989}$ , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1989.

Complete application of the water to the proposed use shall be made on or before October 1, 1990.
