PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11694 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to North American Tree Company dba Portland Nursery, of 5050 S.E. Stark, Portland 97215, phone 231-5050, for the use of water from one well,

for the PURPOSE of watering of containerized nursery stock,

that the PRIORITY OF THE RIGHT dates from September 2, 1987,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 80.0 gallons per minute

measured at the point of diversion from the well, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 225 feet South and 2350 feet East from the Northwest corner of Section 6, being within the NE1/4 NW1/4 of Section 6, Township 1 South, Range 2 East, W.M., in the County of Multnomah.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 1 South, Range 2 East, W.M., Section 6 NE1/4 NW1/4 4.6 acres containers

The right allowed herein shall be limited to appropriation of water only to the extent that it does not impair or substantially interfere with prior surface water rights, as well as ground water rights of others, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before December 31, 1988 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89.

Complete application of the water to the proposed use shall be made on or before October 1, 19 90.
