## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11665 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Clermont Fruit Packers, Inc. of P.O. Box 604, Hillsboro, Oregon 97123, phone 648-8544, for the use of water from one well,

for the PURPOSE of industrial uses in the processing of fresh fruits, including washing of fruit and equipment, cooling of finished product, drinking and general plant use,

that the PRIORITY OF THE RIGHT dates from June 22, 1987,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 70.0 gallons per minute,

measured at the point of diversion from the well, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 3325 feet South and 1500 feet West from the Northeast corner of Monroe D.L.C. 44, being within the NW1/4 SW1/4 of Section 15, Township 1 North, Range 3 West, W.M., in the County of Washington.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 1 North, Range 3 West, W.M., Section 15 NW1/4 SW1/4 Industrial

The use of water under the right allowed herein shall be limited to appropriation of water only to the extent that it does not impair or substantially interfere with prior surface water rights of others, as well as ground water rights.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before February 28, 1989, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 90 .
