PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11443 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Ronald C. Nunn of 3853 Leonard Road of Grants Pass, Oregon 97527, phone 479-4178, for use of the waters from five wells,

for the PURPOSE of domestic supplies for 308 families and commercial uses to include three laundromats, two restaurants, one grocery store, one drug store, and one office building of 10,000 square-feet, being 0.31 cubic foot per second for * that the PRIORITY OF THE RIGHT dates from October 3, 1985,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.56 cubic foot per second,

measured at the point of diversion from the wells, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well 1 - 375 feet South and 300 feet East from the Center 1/4 Corner of Section 23, being within the NW 1/4 SE 1/4 of Section 23; Well 2 - 340 feet South and 473 feet East from the Center 1/4 Corner of Section 23, being within the NW 1/4 SE 1/4 of Section 23; Well 3 - 150 feet North and 355 feet East **

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

This permit shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with prior surface water rights as well as prior ground water rights of others.

* domestic uses and 0.25 cfs for commercial uses.

** from the Center 1/4 Corner of Section 23, being within the SW 1/4 NE 1/4 of Section 23; Well 4 - 625 feet North and 286 feet West from the Center 1/4 Corner of Section 23, being within the SE 1/4 NW 1/4 of Section 23; Well 5 - 465 feet North and 161 feet West from the Center 1/4 Corner of Section 23, being within the SE 1/4 NW 1/4 of Section 23, all in Township 36 South, Range 6 West, WM, in the County of Josephine.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before February 28, 1989, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1989. Extended to October 1, 1991, 10-1-92, 10-1-97, 10-1-09

Complete application of the water to the proposed use shall be made on or before October 1, 1990 Extended to October 1, 1991, 10-1-92, 10-1-97, 10-1-09,
