PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION and the following limitations and conditions:

G-11646

and do hereby grant the same SUBJECT TO EXISTING RIGHTS

and the following limitations and conditions:

Lewis John Siri of 10061 South Kraxberger Road, Canby, Oregon 97013, phone 266-3798, for the use of water from one well,

for the PURPOSE of

irrigation of 20.15 acres,

that the PRIORITY OF THE RIGHT dates from

May 1, 1987,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed foot per second

0.25 cubic

measured at the point of diversion from the vell , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 92 feet South and 238.43 feet East from the Northwest corner of Lucinda Offield D.L.C. 47, being within the SE1/4 NW1/4 of Section 15, Township 4 South, Range 1 East, W.M., in the County of Clackamas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 4 South, Range 1 East, W.M., Section 15 SE1/4 NW1/4 10.0 acres NE1/4 SW1/4 10.15

The AMOUNT OF WATER used for irrigation, together with the the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre feet per acre for each acre irrigated during the irrigation season of each year, and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with prior surface water rights, as well as ground water rights of others, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before diligence and be completed on or before October 1, 19

March 28, 1989

, and shall thereafter be prosecuted with reasonable

Complete application of the water to the proposed use shall be made on or before October 1, 19
