PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11675 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Glenn Walters Nursery, Inc. of Route 2, Box 389, Forest Grove, Oregon 97116, phone 359-4453, for use of the waters from one well,

m the~PURPOSE~of}$ nursery operations (related nursery use) to include irrigation, and such uses as chemical application, temperture control, and soil moisture control for the PURPOSE of for digging and balling plants,

that the PRIORITY OF THE RIGHT dates from

July 2, 1987 for irrigation June 14, 1988 for nursery operations except

irrigation,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 220.0 gallons per minute,

measured at the point of diversion from the Well , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 1450 feet South and 2410 feet East from the Northwest Corner of Section 22, being within the SE 1/4 NW 1/4 of Section 22, Township 1 South, Range 3 West, WM, in the County of Washington.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer. If used for field irrigation for nursery stock, such use is not restricted to the defined agriculture irrigation season.

Use of water under this permit shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with prior ground water rights of others and limited to the appropriation of water only to the extent that such appropriation does not interfere with or deplete the flow of Tualatin River or any tributary thereof. Any depletion of surface waters may require the well to be shutdown, since use of the waters of the tributary in the vicinity of the well have been withdrawn from appropriation except for storage and use of stored water only and since uses of the waters of Tualatin River and tributaries are restricted to certain uses during the period July 31 through September 15 of each year.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before $\mbox{ June } 16$, $\mbox{ 1989}$, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, $\mbox{ 1990}$.

Complete application of the water to the proposed use shall be made on or before October 1, 1991 .
