PERMIT TO APPROPRIATE THE PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

NATIONAL BANK FOR COOPERATIVES
WEST 601 1ST AVENUE
P.O. BOX TAF-C2
SPOKANE, WASHINGTON 99220-4002

to use the waters of WELL NO. 3 in the MIDDLE WILLAMETTE RIVER BASIN
for the purpose of QUASI-MUNICIPAL USE.

This Permit is issued approving Application G-11825. The date of
priority is JUNE 22, 1988. The use is limited to not more than 0.67
CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured
at the well.

The well is located as follows:

NW 1/4 SE 1/4, SECTION 29, T 6 S, R 3 W, W.M.; 1298 FEET NORTH
AND 5 FEET WEST FROM THE SE CORNER, DLC 54.

The use shall conform to such reasonable rotation system as may be
ordered by the proper state officer.

The use of water under this permit shall be limited to appropriation
of water only to the extent that it does not impair or substantially
interfere with prior surface water rights as well as prior ground
water rights of others.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for a measuring line, adequate to determine water level elevation in the well at all times. When required by the department, the permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before JULY 27, 1990, and shall be completed on or before October 1, 1991. Complete application of the water to the use shall be made on or before October 1, 1992.

This permit is for the beneficial use of water without waste. By law, the land use associated with this water must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights.
