*PERMIT TO APPROPRIATE THE PUBLIC WATERS*

is hereby issued a permit to use groundwater from TWO WELLS, within WILLAMETTE RIVER BASIN, for MUNICIPAL USE. This permit to the use of these waters has been issued under Application G-11806 with a date of priority of DECEMBER 30, 1988 FOR USE OF 4.44 CFS BEING 2.22 CFS FROM EACH WELL, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

WELL 1 SE 1/4 SE 1/4, Section 11, T 3 S, R 1 W, WM;  
1180 FEET NORTH & 700 FEET WEST FROM SE CORNER, SECTION 11.

WELL 2 SE 1/4 SW 1/4, Section 12, T 3 S, R 1 W, WM;  
80 FEET NORTH & 1550 FEET EAST FROM SW CORNER, SECTION 12.

This permit shall be limited to appropriation of water only to the extent that it does not impair or substantially interfere with prior surface water rights as well as prior ground water rights of others, and use of water allowed herein shall be subject to conditions as follows:

1) If the Watermaster finds that municipal use under this permit has resulted in a demonstrable interference with senior rights, the City shall make a reasonable and prudent effort to connect the senior right holders to the municipal water system for the uses of water stated in the senior rights. Alternatively, the City shall make a reasonable and prudent effort to perform or participate in the restoration efforts for the well use of senior right holders. The Water Resources Director shall determine what constitutes a reasonable and prudent effort.

2) Within six months of permit issuance, the City shall prepare a report for the Water Resources Commission which specifies the City's water conservation program. The report shall indicate the means of creating efficiencies of existing City water use and the measures which the City may implement to ensure that inefficiencies are not built into the City's future uses.

3) Within nine months of permit issuance, the City shall review and update Ordinance No. 211, Growth Management Ordinance. A growth management program and procedures will ensure the adequacy of provisions for primary services - including the water system - in relation to building permit allocations.

4) Within one year of permit issuance, the City shall prepare a plan/timetable for the Water Resources Commission which shall indicate the steps which the City intends to pursue to obtain a long-term water supply. The City of Wilsonville understands that reliance on ground water for a long-term water supply is unacceptable.

The use of water allowed under this permit shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The wells shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port measuring line, adequate to determine water level elevation in the well at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

The Water Resources Commission reviewed and considered this proposed project on May 13, 1988.

If the Water Resources Department determines that a well is improperly constructed, the well shall be repaired to state standards. The well owner can provide either evidence to the Water Resources Department that the well meets state standards or the owner can provide another satisfactory alternative.

Actual construction work shall begin on or before August 23, 1990, and shall be completed on or before October 1, 1991. Complete application of the water to the use shall be made on or before October 1, 1992.

This permit is for the beneficial use of water. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan. It is possible that the land use you propose may not be allowed if it is not in keeping with the goals and the acknowledged plan. Your city or county planning agency can advise you about the land-use plan in your area.
