to use the waters of ONE WELL in the MALHEUR LAKE BASIN for BUREAU OF LAND MANAGEMENT COMPLEX USES TO INCLUDE WATER FOR OFFICE AND WAREHOUSE RESTROOMS, WASHING PARKING LOTS, FILLING FIRE TRUCKS AND MAINTENANCE OF FIRE PROTECTION SYSTEM.

This Permit is issued approving Application G-11776. The date of priority is JANUARY 19, 1988. The use is limited to not more than 0.78 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW 1/4 NW 1/4, SECTION 2, T 24 S, R 30 E, W.M.; 1630 FEET SOUTH AND 1090 FEET EAST FROM NW CORNER, SECTION 2.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the permit is as follows:

SW 1/4 NW 1/4  
SECTION 2  
TOWNSHIP 24 SOUTH, RANGE 30 EAST, W.M.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for a measuring line, adequate to determine water level elevation in the well at all times. When required by the department, the permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before , and shall be completed on or before October 1, 1991. Complete application of the water to the use shall be made on or before October 1, 1992.

This permit is for the beneficial use of water without waste. By law, the land use associated with this water must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water shall be limited when it interferes with any prior surface or ground water rights.
