## PERMIT TO APPROPRIATE THE PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

to use the waters of ONE WELL in the PUDDING RIVER BASIN for IRRIGATION OF 67.7 ACRES.

This Permit is issued approving Application G-11996. The date of priority is DECEMBER 11, 1989. The use is limited to not more than 0.85 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW 1/4 SE 1/4, SECTION 31, T 6 S, R 1 W, W.M.; 650 FEET SOUTH AND 440 FEET EAST FROM MOST EASTERLY NE CORNER, DLC 38.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acare irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the permit is as follows:

SW 1/4 NE 1/4 2.7 ACRES SE 1/4 NW 1/4 1.7 ACRES NE 1/4 SW 1/4 9.4 ACRES SE 1/4 SW 1/4 9.4 ACRES NW 1/4 SE 1/4 27.0 ACRES SW 1/4 SE 1/4 17.5 ACRES SECTION 31

TOWNSHIP 6 SOUTH, RANGE 1 WEST, W.M.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a usable access port, and may also include an air line and pressure gauge adequate to determine water level elevation in the well at all times. When required by the department, the permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Prior to receiving a certificate of water right, the permit holder shall submit the results of a pump test meeting the department's standards, to the Water Resources Department. The Director may require water level or pump test results every ten years thereafter.

Actual construction work shall begin on or before MARCH 9, 1991, and shall be completed on or before October 1, 1991. Complete application of the water shall be made on or before October 1, 1992.
