to use the waters of ONE WELL in the GOOSE LAKE BASIN for IRRIGATION AND SUPPLEMENTAL IRRIGATION OF 50.36 ACRES.

This Permit is issued approving Application G-11762. The date of priority is OCTOBER 30, 1989. The use is limited to not more than 0.6 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well. The use allowed herein may be made any time between April 1 to November 15 of each year that water can be put to beneficial use by irrigation for immediate plant growth.

The well is located as follows:

NE 1/4 NE/ 1/4, SECTION 13, T. 39 S., R. 19 E., W.M. -- 480 FEET SOUTH AND 320 FEET WEST FROM THE NE CORNER OF SECTION 13..

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated.

The use of water shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the period April 1 to September 30, of each year and shall be further limited to a diversion of not to exceed 0.75 acre-foot for each acre irrigated during an extension of the irrigation season, being the period from October 1 to November 15, of each year. Provided further that the right allowed herein shall not exceed 3.0 acre-feet for each acre irrigated in any one year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the permit is as follows:

PRIMARY SUPPLY AND EXTENDING THE IRRIGATION SEASON FOR

NE 1/4 NE 1/4 2.6 ACRES

ALL IN SECTION 13,
TOWNSHIP 39 SOUTH, RANGE 19 EAST, W.M.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for a measuring line, adequate to determine water level elevation in the well at all times. When required by the department, the permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before January 14, 1992, and shall be completed on or before October 1, 1992. Complete application of the water to the use shall be made on or before October 1, 1993.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights.
