to use the waters of ONE WELL in the WILLAMETTE RIVER BASIN for PRIMARY AND SUPPLEMENTAL IRRIGATION OF 74.4 ACRES.

This Permit is issued approving Application G-11963. The date of priority is SEPTEMBER 18, 1989. The use is limited to not more than 0.93 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE 1/4 SE 1/4, SECTION 17, T 6 S, R 3 W, W.M.; 350 FEET NORTH AND 1250 FEET WEST FROM SE CORNER, SECTION 17.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the permit is as follows:

NE 1/4 SW 1/4 3.8 ACRES SE 1/4 SW 1/4 1.8 ACRES NE 1/4 SE 1/4 9.0 ACRES NW 1/4 SE 1/4 17.2 ACRES SW 1/4 SE 1/4 26.0 ACRES SE 1/4 SE 1/4 16.6 ACRES SECTION 17

TOWNSHIP 6 SOUTH, RANGE 3 WEST, W.M.

The use of water under this permit for supplemental irrigation of lands having existing rights does not in any way relinguish any rights to surface water under Certificates 15059 and 24429.

By issuance of this permit, authority to use water under Certificates 15059 and 24429 from the well to the extent that the use does not interfere with any prior right is hereby approved.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for a measuring line, adequate to determine water level elevation in the well at all times. When required by the department, the permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before April 22, 1992, and shall be completed on or before October 1, 1993. Complete application of the water to the use shall be made on or before October 1, 1994.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights.
