PERMIT TO APPROPRIATE THE PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

to use the waters of TWO WELLS in the BALM FORK BASIN for IRRIGATION OF 17.3 ACRES AND SUPPLEMENTAL IRRIGATION OF 42.9 ACRES.

This Permit is issued approving Application G-11937. The date of priority is JUNE 19, 1989. The use is limited to not more than 0.75 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SE 1/4 SE 1/4, SECTION 2; SW 1/4 NE 1/4, SECTION 12, T 3 S, R 26 E, W.M.; WELL 1 - 270 FEET NORTH AND 820 FEET WEST FROM SE CORNER, SECTION 2; WELL 2 - 2600 FEET SOUTH AND 3300 FEET EAST FROM NW CORNER, SECTION 12.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land. The quantity of water allowed herein along with the amount secured under any other right shall not exceed the capacity of the well at the time of perfection of this right.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the permit is as follows:

The wells shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for a measuring line, adequate to determine water level elevation in the wells at all times. When required by the department, the permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before MAY 20, 1992, and shall be completed on or before October 1, 1993. Complete application of the water to the use shall be made on or before October 1, 1994.

This permit is for the beneficial use of water without waste. By law, the land use associated with this water must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights.
