to use the waters of THREE WELLS in the SQUAW CREEK BASIN for DOMESTIC USE EXPANDED FOR 380 FAMILIES.

This Permit is issued approving Application G-11899. The date of priority is MARCH 13, 1989 FOR 0.223 CUBIC FOOT PER SECOND (CFS) AND AUGUST 23, 1991 FOR 0.623 CFS. The use is limited to not more than 0.846 CFS, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

WELL 1 - NW 1/4 SW 1/4, SECTION 1, T 16 S, R 10 E, W.M.; 1148 FEET SOUTH AND 46 FEET EAST FROM NW CORNER, SECTION 1;

WELL 2 - NW 1/4 NW 1/4, SECTION 33, T 15 S, R 11 E, W.M.; 151 FEET SOUTH AND 823 FEET EAST FROM W 1/4 CORNER, SECTION 33;

WELL 3 - NW 1/4 NW 1/4, SECTION 13, T 16 S, R 10 E, W.M.; 2028 FEET NORTH AND 270 FEET EAST FROM W 1/4 CORNER, SECTION 13.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a usable access port, and may also include an air line and pressure gauge adequate to determine water level elevations in the well at all times. When required by the Department, the permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Prior to receiving a certificate of water right, the permit holder shall submit the results of a pump test meeting the Department's standards, to the Water Resources Department. The Director may require water level or pump test results every ten years thereafter.

Actual construction work shall begin on or before September 3, 1992, and shall be completed on or before October 1, 1993. Complete application of the water shall be made on or before October 1, 1994. B+C ext - 10-1-98

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for beneficial use of water without waste. The water user is advised that new regulations may require use of best practical The water technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water shall be limited when it interferes with any prior surface or ground water rights. extended to .
