THIS PERMIT IS HEREBY ISSUED TO

to use the waters of ONE WELL in the FIFTEENMILE CREEK BASIN for IRRIGATION OF 40.0 ACRES.

This Permit is issued approving Application G-12059. The date of priority is APRIL 2, 1990. The use is limited to not more than 0.445 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW 1/4 SW 1/4, SECTION 32, T 2 N, R 14 E, W.M.; 1190 FEET NORTH AND 1200 FEET EAST FROM SW CORNER, SECTION 32.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the permit is as follows:

NW 1/4 SW 1/4 7.9 ACRES SW 1/4 SW 1/4 16.9 ACRES SE 1/4 SW 1/4 13.7 ACRES SW 1/4 SE 1/4 1.5 ACRES SECTION 32

TOWNSHIP 2 NORTH, RANGE 14 EAST, W.M.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a usable access port, and may also include an air line and pressure gauge adequate to determine water level elevations in the well at all times. When required by the department, the permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Prior to receiving a certificate of water right, the permit holder shall submit the results of a pump test meeting the department's standards, to the Water Resources Department. The Director may require water level or pump test results every ten years thereafter.

Actual construction work shall begin on or before September 9, 1992, and shall be completed on or before October 1, 1993. Complete application of the water shall be made on or before October 1, 1993. Canceled Sp. 0. vol. 50 p. 33
