## PERMIT TO APPROPRIATE THE PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

HIGHLAND SUBDIVISION WATER DISTRICT 435 AKINS LANE PRINEVILLE, OREGON 97754

to use the waters of WELL # 2 in the CROOKED RIVER BASIN for DOMESTIC SUPPLIES FOR 150 DWELLINGS INCLUDING UP TO ONE-HALF ACRE OF LAWN AND NON-COMMERCIAL GARDEN FOR EACH.

This permit is issued approving Application G-12289. The date of priority is NOVEMBER 9, 1990. The use is limited to not more than 200 GALLON PER MINUTE, or its equivalent in case of rotation, measured at the well and should allow groundwater production from no shallower than 100 feet below land surface.

The well is located as follows:

NE 1/4 NW 1/4, SECTION 30, T 15 S, R 16 E, W.M.; WELL 2 - 70 FEET SOUTH AND 2360 FEET EAST, FROM THE NW CORNER, SECTION 30.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the permit is as follows:

NE 1/4 SW 1/4
SE 1/4
SECTION 29
TOWNSHIP 15 SOUTH, RANGE 16 EAST, W.M.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a usable access port, and may also include an air line and pressure gauge adequate to determine water level elevation in the well at all times. When required by the department, the permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Prior to receiving a certificate of water right, the permit holder shall submit the results of a pump test meeting the department's standards, to the Water Resources Department. The Director may require water level or pump test results every ten years thereafter.

Actual construction work shall begin on or before September 23, 1992, and shall be completed on or before October 1, 1993. Complete application of the water shall be made on or before October 1, 1994.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.
