to use the waters of WELLS 2 & 3 in the EAST CHAMPOEG CREEK BASIN for IRRIGATION OF 105.0 ACRES.

This permit is issued approving Application G-12414. The date of priority is FEBRUARY 19, 1991. The use is limited to not more than 1.31 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

SW 1/4 SW 1/4, SECTION 10, NE 1/4 SE 1/4, SECTION 9, T 5 S, R 2 W, W.M.; WELL 2 - 1250 FEET NORTH AND 850 FEET EAST, WELL 3 - 1500 FEET NORTH AND 660 FEET WEST, BOTH FROM SW CORNER, SECTION 10.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this permit is as follows:

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a usable access port, and may also include an air line and pressure gauge adequate to determine water level elevation in the well at all times. When required by the department, the permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Prior to receiving a certificate of water right, the permit holder shall submit the results of a pump test meeting the department's standards, to the Water Resources Department. The Director may require water level or pump test results every ten years thereafter.

The use of water shall be limited when it interferes with any prior surface or ground water rights.
