THIS PERMIT IS HEREBY ISSUED TO

to use the waters of THREE WELLS in the CHENOWETH CREEK BASIN for IRRIGATION OF 80.0 ACRES.

This permit is issued approving Application G-12452. The date of priority is MARCH 20, 1991. The use is limited to not more than 120.0 GALLONS PER MINUTE (GPM), BEING 40.0 GPM FROM EACH WELL, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

SW 1/4 NE 1/4, SE 1/4 NE 1/4, SECTION 31, T 2 N, R 13 E, W.M.; WELL 1 - 889.13 FEET NORTH AND 2304.34 FEET WEST, WELL 2 - 315.23 FEET NORTH AND 2155.60 FEET WEST, WELL 3 - 32.98 FEET NORTH AND 743.06 FEET WEST, ALL FROM E 1/4 CORNER, SECTION 31.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this permit is as follows:

SW 1/4 NE 1/4 40.0 ACRES SE 1/4 NE 1/4 40.0 ACRES SECTION 31 TOWNSHIP 2 NORTH, RANGE 13 EAST, W.M.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a usable access port, and may also include an air line and pressure gauge adequate to determine water level elevation in the well at all times. When required by the department, the permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Prior to receiving a certificate of water right, the permit holder shall submit the results of a pump test meeting the department's standards, to the Water Resources Department. The Director may require water level or pump test results every ten years thereafter.

Actual construction work shall begin on or before January 6, 1993, and shall be completed on or before October 1, 1993. Complete application of the water shall be made on or before October 1, 1994.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.
