## PERMIT TO APPROPRIATE THE PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

to use the waters of TWO WELLS in the PALMER CREEK BASIN for IRRIGATION OF 47.7 ACRES.

This permit is issued approving Application G-12353. priority is DECEMBER 18, 1990. The use is limited to not more than 0.6 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

LOT 3 (SE 1/4 NW 1/4), NE 1/4 SW 1/4, SECTION 1, T 5 S, R 4 W, W.M.; WELL 1 - 570 FEET SOUTH AND 1750 FEET EAST, WELL 2 - 230 FEET SOUTH AND 2000 FEET EAST, BOTH FROM NW CORNER GRAHAM DLC 39.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this permit is as follows:

> NE 1/4 SW 1/4 12.2 ACRES SW 1/4 SW 1/4 0.5 ACRE

> SE 1/4 SW 1/4 NW 1/4 SE 1/4 23.4 ACRES

> 7.8 ACRES SW 1/4 SE 1/4 3.8 ACRES

SECTION 1

TOWNSHIP 5 SOUTH, RANGE 4 WEST, W.M.

The wells shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a usable access port, and may also include an air line and pressure gauge adequate to determine water level elevation in the well at all times. When required by the department, the permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Prior to receiving a certificate of water right, the permit holder shall submit the results of a pump test meeting the department's standards, to the Water Resources Department. The Director may require water level or pump test results every ten years thereafter.

Actual construction work shall begin on or before April 27, 1993, and shall be completed on or before October 1, 1994. Complete application of the water shall be made on or before October 1, 1995.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.
