to use the waters of A WELL in the WILLAMETTE RIVER BASIN for IRRIGATION OF 129.0 ACRES.

This permit is issued approving Application G-12487. The date of priority is APRIL 16, 1991. The use is limited to not more than 1.61 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW 1/4 NW 1/4, SECTION 3, T 4 S, R 2 W, W.M.; 1150 FEET NORTH AND 35 FEET EAST FROM E 1/4 CORNER, SECTION 4.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this permit is as follows:

> NW 1/4 NW 1/4 10.5 ACRES

> SW 1/4 NW 1/4 27.5 ACRES

> NW 1/4 SW 1/4 21.5 ACRES

SECTION 3

NE 1/4 NE 1/4 15.0 ACRES SE 1/4 NE 1/4 29.5 ACRES

NE 1/4 SE 1/4 25.0 ACRES

SECTION 4

TOWNSHIP 4 SOUTH, RANGE 2 WEST, W.M.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a usable access port, and may also include an air line and pressure gauge adequate to determine water level elevation in the well at all times. When required by the department, the permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Prior to receiving a certificate of water right, the permit holder shall submit the results of a pump test meeting the department's standards, to the Water Resources Department. The Director may require water level or pump test results every ten years thereafter.

Actual construction work shall begin on or before September 28, 1993, and shall be completed on or before October 1, 1994. Complete application of the water shall be made on or before October 1, 1995.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.
