This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceedQa49....... cubic feet per second measured at the point of diversion from the well or source of appropriation, or its equivalent in case of rotation with other water users, from . A. Well. The use to which this water is to be applied is supplemental irrigation or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed .2\frac{1}{2}........... acre feet per acre for each acre irrigated during the irrigation season of each year; provided further... that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.
