PERMIT TO APPROPRIATE THE PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

to use the waters of TWO WELLS in the BUTTE CREEK BASIN for IRRIGATION OF 77.0 ACRES.

This permit is issued approving Application G-13260. The date of priority is JANUARY 22, 1993. The use is limited to not more than 0.96 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

SW 1/4 NW 1/4, SE 1/4 NW 1/4, SECTION 26, T 5 S, R 1 W, W.M.; WELL 1 - 5 FEET NORTH AND 30 FEET EAST, WELL 2 - 470 FEET NORTH AND 1870 FEET EAST, BOTH FROM THE W 1/4 CORNER OF SECTION 26.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. The period of allowed use is March 1 through October 31.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this permit is as follows:

NW 1/4 NW 1/4 5.7 ACRES
SW 1/4 NW 1/4 36.3 ACRES
SE 1/4 NW 1/4 35.0 ACRES

SECTION 26

TOWNSHIP 5 SOUTH, RANGE 1 WEST, W.M.

The wells shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a usable access port, and may also include an air line and pressure gauge adequate to determine water level elevation in the wells at all times.

Measurement, recording and reporting conditions:

- A. Before water use may begin under this permit, the permittee shall install a meter or other suitable measuring device as approved by the Director. The permittee shall maintain the meter or measuring device in good working order.
- B. The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.
- C. The Director may require the permittee to keep and maintain a record of the amount (volume) of water used and may require the permittee to report water use on a periodic schedule as established by the Director.
