SOURCE OF WATER: A QUARRY WITHIN THE WILLAMETTE BASIN

PURPOSE OR USE: DEWATERING FOR QUARRY OPERATIONS

AMOUNT/VOLUME OF WATER ALLOWED: 2.45 CFS (1100 GALLONS PER MINUTE)

PERIOD OF ALLOWED USE: YEAR ROUND

DATE OF PRIORITY: OCTOBER 3, 1991

POINT OF DIVERSION LOCATION: NW 1/4 NW 1/4, SECTION 3, T3S, R1W, W.M.,
1500 FEET NORTH AND 370 FEET EAST FROM THE W 1/4 CORNER SECTION 3

THE PLACE OF USE IS LOCATED WITHIN THE SW 1/4 NW 1/4, SECTION 3,
TOWNSHIP 3 SOUTH, RANGE 1 WEST, W.M.

Measurement, recording and reporting conditions:

- A. Before water use may begin under this permit, the permittee shall install a meter or other suitable measuring device as approved by the Director. The permittee shall maintain the meter or measuring device in good working order, shall keep a complete record of the amount of water used each month and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the permittee to report general water use information, including the place and nature of use of water under the permit.
- B. The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

Water use under this permit may be subject to regulation to satisfy prior rights on Rock Creek.

As used in the following conditions, "well" means any artificial opening or artificially altered natural opening, however made, by which ground water is sought or through which ground water flows under natural pressure or is artificially withdrawn.

No pump test shall be required of any well included in this permit with a diameter greater than 36 inches and a depth less than 30 feet.

If substantial interference with a senior water right occurs due to withdrawal of water from any well listed on this permit, then use of water from the well(s) shall be discontinued or reduced and/or the schedule of withdrawal shall be regulated until or unless the Department approves or implements an alternative administrative action to mitigate the interference. The Department encourages junior and senior appropriators to jointly develop plans to mitigate interferences.

STANDARD CONDITIONS

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.


By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water shall be limited when it interferes with any prior surface or ground water rights.

The Director finds that the proposed use(s) of water described by this permit, as conditioned, will not impair or be detrimental to the public interest.

Actual construction of the well or other means of developing and securing groundwater shall begin within one year from permit issuance, and shall be completed on or before October 1, 1997. Complete application of the water to the use shall be made on or before October 1, 1998.
